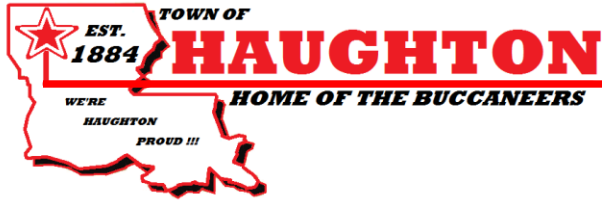

Welcome to the Town of Haughton!

- Please see the attached water and sewer rates for residential, commercial, both in and out of town limit rates. Your water service will be billed as **Class 1**.
- Water bills can be mailed in along with your stub or paid at the Town Hall from 8:30 am – 4:00 pm, Monday – Thursday, and 8:30 am – 12:00 pm on Fridays. Payments may also be dropped after hours in the night box located directly to the left of the front door. Also, you can pay by credit/debit card online at www.haughtonla.gov or by telephone at 318-706-5312. We accept cash, check, money orders, and all major credit cards. **If you have more than one meter, you will be required to make separate payments for each meter**
- All water bills are due on the **15th of each month**. If the balance is not paid by the open of business day on the 16, a 10% late charge will be added.
- **Any bills not paid by the 24th of each month will be charged a \$50.00 administrative fee. On the 25th or after, all unpaid accounts are subject to disconnection. Service will not be restored until the FULL balance is paid with the \$50.00 administrative fee. NO EXCEPTIONS. (Ordinance 2 of 2016)**
- Please know that it is a violation of Louisiana Law to cut meter locks or otherwise tamper with meters. Violators will be prosecuted.
- Garbage service is provided by Live Oak Environmental and is included in your monthly water bill. The pickup day for your service address is **located on the top of your trash can**.
- **Your payment today covers the \$120.00 refundable deposit and the \$100.00 non-refundable meter maintenance fee.**

I understand that if I do not pay, my account will be sent to collections and additional fees will be applied and it could affect my credit.
