TOWN OF HAUGHTON COUNCIL MEETING

SEPTEMBER 14TH, 2021

THE COUNCIL MEETING WAS HELD AT THE HAUGHTON TOWN HALL ON TUESDAY, SEPTEMBER 14TH, 2021 AT 6:00 P.M.

COUNCIL MEMBERS PRESENT WERE DOUG ADAMS, COLBY ISOM, BUCK MCGEE, PHILLIP SMITH AND CARLTON ANDERSON.

THE MEETING WAS PRESIDED OVER BY MAYOR KIM GASPARD.

NEIL ERWIN, TOWN ATTORNEY, WAS PRESENT.

THE MEETING WAS OPENED WITH PRAYER BY PHILLIP SMITH AND THE PLEDGE OF ALLEGIANCE WAS LED BY CARTLON ANDERSON.

THERE WERE A NUMBER OF CITIZENS ATTENDING.

CHIEF HOLLAND GAVE THE FIRE DEPARTMENT MONTHLY REPORT. HE STATED ALL APPARATUS ARE IN SERVICE. HE STATED THAT DAILY TRAINING CONTINUES FOR FULL TIME PERSONNEL. HE STATED THAT THE OPEN POSITION ON THE C-SHIFT HAS BEEN FILLED BY SPENCER LEON, A HAUGHTON HIGH SCHOOL GRADUATE OF 2006. THE AERIAL CLASS HAS BEEN RESCHEDULED FOR OCTOBER 18-22. FIREFIGHTER, DUSTIN HICKS, HAS CERTIFIED TO THE OFFICER II LEVEL. COVID-19 VACCINATION DRIVE WAS HELD AUGUST 28TH. OVER 50 INDIVIDUALS WERE VACCINATED. THE SECOND ROUND OF SHOTS WILL BE ADMINISTERED ON SEPTEMBER 18TH.

CHIEF GIBSON GAVE THE POLICE DEPARTMENT MONTHLY REPORT. HE STATED THAT ALL OFFICERS SUCCESSFULLY REQUALIFIED WITH PISTOLS, RIFLES AND SHOTGUNS, THEY WILL HAVE A NIGHT SHOOT THIS FALL. HE ALSO STATED THAT RESERVES ARE NOW REQUIRED TO VOLUNTEER AT LEAST 16 HOURS PER MONTH. HE STATED THAT THIS HAS BEEN A VERU BUSY MONTH OF DRUG ARRESTS, DISORDERLY SUBJECTS, FUGITIVE ARRESTS, AND DOMESTICS. HE ALSO STATED THAT THE SCHOOL BOARD IS PAYING FOR 4 HPD OFFICERS AND 4 BSO DEPUTIES PER HHS HOME GAME. THIS IS DUE TO THE LIMITED AMOUNT OF PARKING AT THE SCHOOL. SCHOOL BUSES ARE SHUTTLING FROM 1ST BAPTIST TO THE SCHOOL.

PUBLIC WORKS DIRECTOR HICKS GAVE DEPARTMENT MONTHLY REPORT. HE STATED THAT NINE NEW METERS WERE INSTALLED. A DAMAGED HYDRANT WAS REPLACED ON SLIGO ROAD. AND REPAIRED NUMEROUS SERVICE LINES AROUND TOWN.
